The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00hrs on 10th Jestha 2083 (24th May 2026)** at the office of Bihadi rural Municipality, Office of Municipal executive, wahakithanti parbat. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. **70,000** which shall be valid for 30 days beyond the validity period of the bid.
